ADDITIONAL TOURNAMENT RULES

These additional tournament rules (the "Rules") govern your participation in the optional Virtual Live Scholarship Event (the "Tournament"). 1. GENERAL OBLIGATIONS

The Tournament is open to full-time 12th grade students who: (a) currently attend an accredited high school in Allegheny, Beaver, Butler, Washington or Westmoreland County, Pennsylvania (the "Pittsburgh Area"); Cuyahoga, Lake, Lorain, Summit or Medina County, Ohio (the "Cleveland Area"); or the City of Virginia Beach, Chesapeake, Norfolk or Portsmouth (the "Hampton Roads Area"); and expect to graduate in June, 2022¹; All participants who are under the age of 18, must receive the written permission of a parent or legal guardian addressed to Dollar Bank Scholarship Tournament, 1009 Freeport Road, Pittsburgh, PA 15238 indicating the minor's name, and that the minor is eligible to participate in the Tournament. To be eligible for the Tuition Scholarship, you do not have to attend the Tournament.
