

DOLLAR BANK 2026 SCHOOL IS IN SESSION SWEEPSTAKES OFFICIAL RULES

1. **TO ENTER:** By scheduling an appointment online and attending the appointment between 8/17/26 and 8/31/26, you are automatically entered for a chance to win the 2026 School is in Session Sweepstakes (the "Sweepstakes") prize and agree to be bound by the official rules of the sweepstakes.
