

DOLLAR BANK 2026 FALL IN LOVE WITH YOUR HOME AGAIN SWEEPSTAKES OFFICIAL RULES

- 1. HOW TO ENTER:** By submitting a completed application for consumer credit for home improvement purposes between 9/01/26 and 10/31/26 (the "Entry Period"), you are automatically entered for a chance to win the 2026 Fall In Love With Your Home Again Sweepstakes (the "Sweepstakes") prize and agree to be bound by these official rules of the Sweepstakes.
