

## **DOLLAR BANK'S 2025 REFER A FRIEND SWEEPSTAKES OFFICIAL RULES**

### **NO PURCHASE OR TRANSACTION NECESSARY.**

**1. TO ENTER:** Dollar Bank's 2025 Refer a Friend Sweepstakes (the "Sweepstakes") will run from 12:00 AM EST on November 5<sup>th</sup>, 2025 until 11:59 PM EST on December 31<sup>st</sup>, 2025.

Enter in any one of the following ways:

a. Current Dollar Bank retail checking customers are automatically entered by referring a friend or family member to open a Dollar Bank retail checking account. To make a referral, visit [dollar.bank/refer](http://dollar.bank/refer) to create a referral account profile. Then, invite a friend or family member using email or MMS Text via the "Send Email or Text" feature found within the [dollar.bank/refer](http://dollar.bank/refer) account profile.

b. Non-Dollar Bank retail checking customers are automatically entered when a current Dollar Bank retail checking customer refers them using email or MMS Text via the "Send Email or Text" feature found within the current retail checking customer's [dollar.bank/refer](http://dollar.bank/refer) account profile.

The referral must be completed by 11:59 PM EST on December 31<sup>st</sup>, 2025 in order for both the referring and the referred to be entered into the Sweepstakes.

c. To enter by mail, please hand-print your name, address, city, state, zip code, telephone number, email address and the words "Dollar Bank's 2025 Refer A Friend Sweepstakes" on a 3" x 5" card and mail the card in a stamped envelope to Dollar Bank Marketing Dept, 20 Stanwix St, 19th Floor, Pittsburgh, PA 15222. Mail-in entries must be postmarked during the Entry Period and received no later than the drawing date. Entries produced by mechanical or other means are void. Only one entry per stamped envelope will be accepted. Mailed entries become the property of the Dollar Bank.

Limit five (5) entries per person.
