

DOLLAR BANK 2026 FINANCIAL CHECK-UP SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR TRANSACTION NECESSARY.

- 1. TO ENTER:** By scheduling an appointment online and attending the appointment between 5/1/26 and 5/30/26, you are automatically entered for a chance to win the 2026 Financial Check-Up Sweepstakes (the "Sweepstakes") prize and agree to be bound by the official rules of the sweepstakes. Sweepstakes begins on 5/1/26 and will be in effect until the end of office hours on 5/31/25. Appointment must be scheduled and completed by 5/31/26. Limit one entry per person during the sweepstakes.
